In this capacity my Deputies are responsible for the capture of numerous wanted fugitives the recovery of illegal narcotics and the recovery of numerous articles of stolen property.

As stated previously I am a strong proponent of the Second Amendment and have personally helped promote the safe use of firearms. I believe that as long as an individual is properly trained and passes a proper background check they should be allowed to carry a concealed weapon and that includes on college campuses.
